## **Special Note:-**

- (i) All Government Accounts maintained by the Bank's branches shall be exempted from the levy of all types of service charges.
- (ii) 10% concession shall be applicable to the institutions falling under the co-operative fold, Boards, Corporations, Welfare Trusts, Ex-Servicemen and Senior Citizens on issue of drafts, MTs and collection of cheques etc. over the prevailing rates.
- (iii) Staff members/Ex Employees of the bank are exempted from charges on issue of drafts, MTs, collection of chaques, local /outstation chaques etc.
- (iv) Locker Rent: 50% concession to staff members/Ex Employees of bank.
